<b>For the following:</b>	New Medical Research Building, including: <ul style="list-style-type: none"><li>• demolition, earthworks and excavation.</li><li>• construction of a five storey building with external bridge connections to adjacent buildings.</li><li>• use as a medical research facility including clinical consultation, treatment and storage rooms, educational amphitheatre and seminar rooms, reception, maintenance, plant, administration areas and a new service bay with access to Parkside Crescent.</li><li>• landscaping works and public domain improvements including the creation of a village green, additional at-grade landscaping, new access paths and ramps and plantings on terraces.</li><li>• removal of one existing on-street car parking space at Parkside Crescent and conversion of two existing at-grade car parking spaces within the hospital campus as accessible.</li><li>• provision of 12 additional bicycle parking spaces.</li><li>• two signage zones.</li><li>• removal of three trees.</li></ul>
